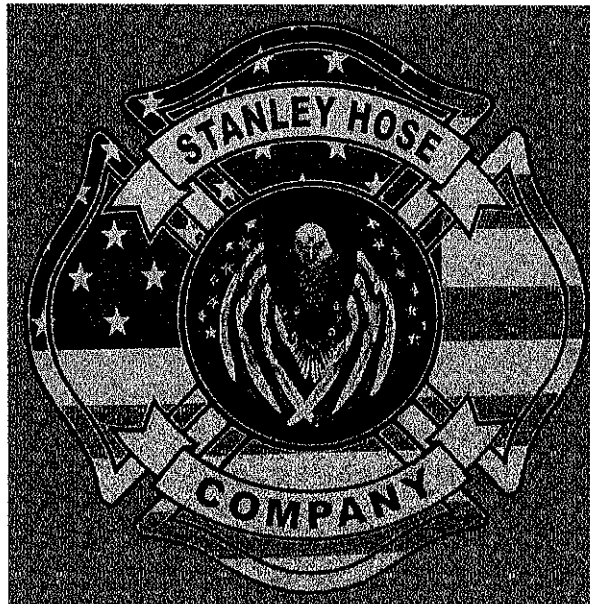

**Stanley Hose Company**  
**Junior Firefighters – Program Guidance**

- Junior Firefighters shall be age 16 or 17.
- Junior Firefighters must live in the Stanley Hose Company's fire district.
- Junior Firefighters must have a current physical from a physician stating they are fit to perform firefighting duties.
- Junior Firefighters may not leave school for any call.
- Junior Firefighters must respond directly to the firehall for calls. They cannot respond directly to scenes unless they are accompanied by a senior member of the SHC.
- Junior Firefighters are to maintain their grades at school. If at anytime a junior firefighter is failing 2 or more courses, they will be suspended from the SHC until such grades are brought up.
- Junior Firefighters are expected to behave in matter that represents the SHC well. Unbecoming behavior in school, the community, or on a call could lead to suspension from the SHC.
- Junior Firefighters are allowed to ride apparatus but must give up their seat to senior members. Arrangements will be made to get junior members to calls if there is no room on apparatus.
- Junior Fighters will not be issued emergency lights for their vehicles and will not drive in an emergency manner to the firehall.
- Junior Firefighters are not to be at the firehall without a senior member present.
- Junior Firefighters may attend monthly meetings but will not be permitted to vote until they become senior members.
- Junior Firefighters may respond and train in all aspects of a volunteer firefighter and/or EMT, but shall NOT be permitted to assume any duties of an interior firefighter at any fire or emergency incident. Junior Firefighters shall not direct traffic unless they are accompanied by a senior member. The officer in charge at an emergency scene reserves the right to determine if an activity is too dangerous for a junior firefighter to perform.
